

Madam/Sir,

This is to inform you that due to lack of Aadhar validation, NPCI Bank Account verification, institute level and subsequently district level verification of online scholarship applications in time, scholarship (Central & State Share) could not be disbursed to a large number of applicants. Moreover, huge number applications remained unverified due to non-verification/ Aadhaar validation of data of Nodal teachers.

It is, therefore, requested to take necessary action for completion of verification & correction of data mismatch at different levels within 30.04.2023 (verification of Caste Certificate mismatch, Banglar Shiksha Portal, AADHAAR, Bank details etc.) for successful payment of different types of scholarship schemes to LOCs.


